MINUTES OF THE MEETING OF ODISHA STATE SEED SUB-COMMITTEE FOR AGRICULTURAL CROPS HELD ON 09.09.14 AT 12NOON IN THE CONFERENCE HALL OF RAJIV BHAWAN UNDER THE CHAIRMANSHIP OF PRINCIPAL SECRETARY TO GOVERNMENT, AGRICULTURE DEPARTMENT, ODISHA, BHUBANESWAR.

The Meeting of Odisha State Seed Sub Committee for Agricultural crops was held on 09.09.14 at 12noon in the Conference Hall of Rajiv Bhawan under the chairmanship of Principal Secretary to Govt. Agriculture Deptt., Odisha, Bhubaneswar. At the outset the Chairman welcomed all the members and advised Director of Agriculture & Food Production, Odisha to initiate the agenda wise discussion.

Confirmation of the proceedings of last State Seed Sub-Committee meeting for Agricultural crops held on 25.01.2012:

The proceedings of the last meeting of Odisha State Seed Sub-Committee for Agricultural crops held on **25.01.2012** has been circulated vide Directorate of Agriculture Letter No-2M (05)144/2011-211, dated 07.02.2012. Since no comments have been received on the minutes of the meeting, it was confirmed.

Action taken on the proceedings of the last meeting held on 25.01.2012:

23 Paddy and non paddy varieties were released by the State Seed Sub Committee for Agricultural Crops vide No.2M(05)144/2011-223/Agril.dt9.2.12 and sent for Notification. The Central Seed Sub-Committee on Crop Standards, Notification and Release of Varieties for Agricultural Crops has recommended for notification of above 15 paddy varieties except Jyotirmayee(delay in production of IC no. by Breeder). Similarly the proposal of Urd bean is not considered. One Toria, two sesame, and two sugarcane varieties differed for notification due to incomplete AICRIP trial data, no morphological character, no glossy photographs and NBPGR certificate in case of Neelachakra. The notification of these varieties of the Central Government was still awaited except Mesta variety Shanti and Hybrid paddy variety Arize Dhani which were notified vide S.O No952(E)/10.4.13 and 2187(E)/19.9.13 respectively. The Chairman advised Dean of Research, OUAT to comply with the queries immediately for onward transmission to Govt. of India. Dean of Research informed that the compliance reports have been prepared & will be submitted soon to Joint Director of Agriculture (Farm & Seeds).

Regarding consideration of proposals for release of new crop varieties proposed by different organization, the Chairman wanted to know the varietal development procedure and multi location trials conducted in different parts of the country including Odisha. Dean of Research, OUAT briefed the Breeding procedure and different trials conducted by AICRP. The house deliberated on the issue of genetic
